DISCUSSION:

BENLIC acquired 249 East St, 149 Northland Ave, 236 Brunswick Blvd, and 702 Norfolk Ave via the 2022 Erie County In-Rem Vacant Auction. These properties are good candidates for BENLIC rehabilitation and are all located in low-income neighborhoods in the City of Buffalo. These properties have been cleaned out and will be fully rehabbed. Funding for the rehabilitation projects is provided by New York State Homes and Community Renewal's Land Bank Initiative program.

The bid package was prepared by the BENLIC Building Inspector and includes house roof replacements, gutter installation, and a garage roof replacement.

The bid was released on November 29th, 2023, with a submission deadline of December 20th, 2023.
