DISCUSSION:

BENLIC acquired 236 Brunswick via the 2022 Erie County In-Rem Vacant Auction. This property is a good candidate for BENLIC rehabilitation and is located in Hamlin Park, a low-moderate income neighborhood which has been designated as an historic preservation district. This property has been cleaned out and will be fully rehabbed. Contractors have already been procured for a roof replacement, removal of an oil storage tank, and asbestos abatement. Funding for this rehabilitation project is provided by New York State Homes and Community Renewal's Land Bank Initiative program.

The bid package was prepared by the BENLIC Building Inspector and includes all remaining parts of the houses not covered by the prior procurements, including carpentry, drywall, plumbing, and fixtures.

The bid was released on February 27th, 2024, with a submission deadline of March 19th, 2024.
