## **DISCUSSION:**

BENLIC acquired 702 Norfolk Avenue via the 2022 Erie County In-Rem Vacant Auction. This property is a good candidate for BENLIC rehabilitation and is located in Fillmore-Leroy, a low-moderate income neighborhood. This property has been cleaned out and will be fully rehabbed. Contractors have already been procured for exterior repairs, including a roof replacement and new windows, doors, and siding repairs. Funding for this rehabilitation project is provided by New York State Homes and Community Renewal's Land Bank Initiative program.

The bid package was prepared by the BENLIC Building Inspector and includes all remaining parts of the houses not covered by the prior procurements, including carpentry, drywall, plumbing, and fixtures.

The bid was released on February 27<sup>th</sup>, 2024, with a submission deadline of March 19<sup>th</sup>, 2024.
